All requests to address the Commission on public hearing items must be submitted prior to the Commission's consideration of the item. **EVERY PERSON WISHING TO ADDRESS THE COMMISSION MUST COMPLETE A SPEAKER'S REQUEST FORM AND SUBMIT IT TO THE COMMISSION STAFF.**

***Written submissions are governed by Rule 10 of the Los Angeles City Planning Commission Rules and Operating Procedures, a copy of which is posted online at [http://planning.lacity.org/Forms\\_Procedures/CPCPolicy.pdf](http://planning.lacity.org/Forms_Procedures/CPCPolicy.pdf). Day of hearing submissions (20 copies must be provided) are limited to 2 pages plus accompanying photographs. Submissions that do not comply with these rules will be stamped "File Copy. Non-Complying Submission." Non-complying submissions will be placed into the official case file, but they will not be delivered to or considered by the CPC, and will not be included in the official administrative record for the item at issue.***

Sign language, interpreters, assistive listening devices, or other auxiliary aids and/or other services may be provided upon request. If you challenge these agenda items in court, you may be limited to raising only those issues you or someone else raised at the public hearing azenized here, or in written correspondence on these matters delivered to this agency at or prior to the public hearing. **If you seek judicial review of any decision of the City pursuant to California Code of Civil Procedure Section 1094.5, the petition for writ of mandate pursuant to that section must be filed no later than the 90th day following the date on which the City's decision became final pursuant to California Code of Civil Procedure Section 1094.6. There may be other time limits which also affect your ability to seek judicial review.**

**PUBLIC HEARING** – Completed February 2, 2017

**PROJECT SITE:** 1 World Way -The Los Angeles International Airport (LAX) Landside Access Modernization Program (LAMP) comprises approximately 860 acres (the "Project Site"). The Project Site is split into three general areas: Central Terminal Area (CTA), East of the CTA and Aviation Boulevard/Imperial Highway. The CTA includes areas west of Sepulveda Boulevard, focused around World Way and the passenger terminals at LAX. East of the CTA is generally bounded by Century Boulevard on the south, Interstate 405 (I-405) on the east, Arbor Vitae Street/LAX property boundary on the north, and the CTA on the west. The Aviation Boulevard/Imperial Highway area is bound by Imperial Highway on the south, 111th Street on the north, Hindry Avenue on the east, and Aviation Boulevard to the west.

**PROPOSED PROJECT:**

The construction, use, and development of the Landside Access Modernization Program, resulting in a new Automated People Mover (APM) system with stations connecting the Central Terminal Area to new ground transportation facilities. The new facilities will include: a Consolidated Rental Car Facility designed to centralize car rental agencies; two Intermodal Transportation Facilities that will provide pick up and drop off areas outside the Central Terminal Area for airport passengers, commercial shuttles, and other ground transportation services, and provide additional facilities for meet and greet areas, passenger processing, retail, dining and other amenities; an APM Maintenance and Storage Facility and traction power substations; and Central Terminal Area APM stations with passenger walkway systems connecting the stations to passenger terminals, with modifications to existing passenger terminals and parking garages within the Central Terminal Area to accommodate walkway system connections and vertical circulation to the arrival, departure, and concourse levels. Proposed roadway improvements are designed to improve access to the Central Terminal Area from the freeway and provide access to the proposed Intermodal Transportation Facilities, Consolidated Rental Car Facility, and public parking facilities; utilities needed to support the LAX LAMP Project; future potential related development on surplus land owned by LAWA located adjacent to the new proposed ground transportation facilities; and amendments to plans regulating land use in the area, including the City of Los Angeles General Plan and the LAX Specific Plan, zone changes, and the reconfiguration of existing parcel as further described below

**REQUESTED ACTIONS TO THE CITY PLANNING COMMISSION:**

1. Pursuant to CEQA Guidelines Sections 15162 and 15164, in consideration of the whole of the administrative record, recommend that the City Council find that the project was assessed in the previously certified Environmental Impact Report No. ENV-2016-3391-EIR, SCH No. 2015021014, certified on March 2, 2007, by the Board of Airport Commissioners, and no subsequent EIR, negative declaration, or addendum is required for approval of the project;
2. Pursuant to procedures set forth in Section 11.5.6 of the Municipal Code and City Charter Sections 555 and 558, recommend that the City Council amend the **LAX Plan** and **LAX General Plan Land Use Map** as part of the General Plan of the City of Los Angeles, as shown in the proposed LAX Plan and Plan Map;
3. Pursuant to procedures set forth in Section 11.5.6 of the Municipal Code and City Charter Sections 555 and 558, recommend that the City Council amend the **Westchester-Playa Del Rey Community Plan General Plan Land Use Designation Map** as part of the General Plan of the City of Los Angeles, as shown in the proposed Plan Map;
4. Pursuant to procedures set forth in Section 11.5.6 of the Municipal Code and City Charter Sections 555 and 558, recommend that the City Council amend **Mobility Plan 2035** as part of the General Plan of the City of Los Angeles, as shown in the proposed Mobility Plan 2035 Amendments;
5. Pursuant to Los Angeles Municipal Code 11.5.7 G and City Charter Section 558, recommend that the City Council amend the **LAX Specific Plan** as part of the General Plan of the City of Los Angeles, as shown in the proposed LAX Specific Plan and Specific Plan Map; and
6. Pursuant to Los Angeles Municipal Code 12.32-F, recommend that the City Council approve the Zone Changes among various properties located within the LAX Plan and the Westchester-Playa Del Rey Community Plan from R3-1, C2-1, and M2-1 to the LAX Zone, and from LAX to the C2-2 Zone, as shown in the proposed Zone Change Maps.
