- 1. Pursuant to Section 12.24.X.26 of the Municipal Code, a **Zoning Administrator's Determination** to allow a 3-foot 6-inch tall retaining wall and a 10-foot 6-inch tall retaining wall to retain the driveway.
- 2. Pursuant to Section 12.24.X.28 of the Municipal Code, a **Zoning Administrator's Determination** to allow a 0-foot front yard setback in lieu of a 20-foot setback for two retaining walls and foundation piles.
- Pursuant to Section 12.20.2 of the Municipal Code, a Coastal Development Permit for the construction of a threestory 1,627-square-foot single-family dwelling on a 4,139-square-foot lot within the dual-permit jurisdiction of the California Coastal Zone.

Recommendation Reports are hyperlinked to the case numbers on the agendas. Please note that Recommendation Reports <u>are not</u> prepared for Hearing Officer or Zoning Administrator hearings.

TESTIMONY AND CORRESPONDENCE - Your attendance is optional; oral testimony can only be given at the public hearing and may be limited due to time constraints. Written testimony or evidentiary documentation may be submitted prior to the hearing. Decision-makers such as Associate Zoning Administrators or Commissions function in a quasity and therefore, cannot be contacted directly. Any materials submitted to the Department or Commission beck to City perty and <u>will not</u> be returned. This includes any correspondence or exhibits used as part of your testimony.

REQUIREMENTS FOR SUBMISSION OF MATERIALS - Written testimony may be subtrained and a size $\frac{1}{2}$ " x 11") or legal size (8 $\frac{1}{2}$ " x 14") paper. All oversized exhibits <u>must be folded</u> to fit into a legal-sized fold. Plans (i.e. plans, floor plans, grading plans) must be presented on paper size not smaller than ledger size (11" x 17"). The case presented on all communications, plans and exhibits. To the extent possible, please <u>also</u> submit all methods.

Regular Submissions

- <u>Matters before Commissions</u>: Written materials not limited as to vote that be <u>received</u> ten (10) days prior to the hearing date. Provide an original plus twelve (12) copies of all prespondence or exhibits. You may submit written testimony to the Commission Office directly at 200 North Spring Secretariat.
- <u>Matters before an Associate Zoning Administic (Action received</u> no later than five (5) days to the hearing date. Provide an original plus (3) copies, and follow the size guidelines above.

Rebuttal Submissions - All write materials response to a Recommendation Report and/or additional comments must be submitted no later than **48 hours** before the hearing at submissions, including exhibits, shall not exceed ten (10) pages.

Day of Hearing Submissions - Successions less than 48 hours prior to, and including the day of the hearing, must not exceed two (2) written pages, including exhibits. Photographs do not count toward the page limitation. Notwithstanding, the Associate Zoning Administrator or Hearing Officer may deviate from this requirement at their discretion.

Non-Complying Submissions - Submissions that do not comply with these rules will be stamped *"File Copy. Non-complying Submission"*. Non-complying submissions will be placed into the official case file, but they will not be delivered to, or considered by the Commission, Associate Zoning Administrator or Hearing Officer. Notwithstanding, the Associate Zoning Administrator or Hearing Officer may deviate from this requirement at their discretion.

EXHAUSTION OF ADMINISTRATIVE REMEDIES AND JUDICIAL REVIEW - If you challenge these agenda items in court, you may be limited to raising only those issues you or someone else raised at the public hearing agenized here, or in written correspondence on these matters delivered to this agency at or prior to the public hearing. If you seek judicial review of any decision of the City pursuant to California Code of Civil Procedure Section 1094.5, the petition for writ of mandate pursuant to that section must be filed no later than the 90th day following the date on which the City's decision became final pursuant to California Code of Civil Procedure Section 1094.5, the petition became final pursuant to California Code of Civil Procedure Section became final pursuant to California Code of Civil Procedure Section 1094.6. There may be other time limits which also affect your ability to seek judicial review.
