PROPOSED PROJECT:

The project is the construction of a new one story 1,878 square foot coffee shop with drive-thru (to operate 24 hours a day) and a two-story, 30,208 square foot mixed used building with a maximum height of 41 feet, with retail uses and a fast food restaurant with drive-thru at grade level and office uses on the second level. A surface parking lot will be located in front of the site and one level of subterranean parking will be located under the new two-story building. A total of 158 parking spaces and 12 short term and 12 long term bike spaces will be provided. New landscaping and trees will be planted around the project site. All existing structures and trees will be removed, which includes a one story, approximate 3,132 square foot building (auto repair garage and office) built in 1988, a one story, approximate 12,835 square foot multi-tenant commercial strip center, built in 1957, and four non-protected trees. An estimated 19,224 cubic yards of earth will be graded and exported.

REQUESTED ACTION(S):

- 1. Based on the whole of the administrative record, the Project is exempt pursuant to CEQA Guidelines, Section 15300, and there is no substantial evidence demonstrating that an exception to a categorical exemption pursuant to CEQA Guidelines Section 15300.2 applies.
- 2. Pursuant to Los Angeles Municipal Code (LAMC) Section 12.24 W.17, a Conditional Use to permit a drive-through fast-food establishment in the [Q]C2-1VL zone which abuts a residential use or zone.

- 3. Pursuant to LAMC Section 12.24 W.27, a Conditional Use to permit a 24 hour operation in lieu of 7 a.m. to 11 p.m. otherwise required, and to maintain an existing pole sign not otherwise allowed per LAMC 12.22.A23.Commercial Corner Development Standards and Operations.
- 4. Pursuant to LAMC Section 12.24 X.22, a Zoning Administrator's Determination to permit a maximum height of 41 feet in lieu of 25 feet and 33 feet (transitional height) otherwise required per LAMC 12.21.1 A.10.

GENERAL INFORMATION

FILE REVIEW - The complete file is available for public inspection between the hours of 8:30 a.m. to 4:00 p.m., Monday through Friday. AGENDAS AND REPORTS- Commission agendas are posted for public review in the Main Street lobby of City Hall East, 200 N. Main Street, Los Angeles, California. Commission Agendas and Hearing Schedules are accessible online at planning.lacity.org. If this matter is before a Commission, please note that a Recommendation Report will be available online seven (7) days prior to the hearing and will be accessible at planning.lacity.org, by selecting "Commissions & Hearings". Recommendation Reports are hyperlinked to the case numbers on the agendas. Please note that Recommendation Reports are not prepared for Hearing Officer or Zoning Administrator hearings.

TESTIMONY AND CORRESPONDENCE - Your attendance is optional; oral testimony can only be given at the public hearing and may be limited due to time constraints. Written testimony or evidentiary documentation may be submitted prior to the hearing. Decision-makers such as Associate Zoning Administrators or Commissions function in a quasi-judicial capacity and therefore, cannot be contacted directly. Any materials submitted to the Department or Commission become City property and will not be returned. This includes any correspondence or exhibits used as part of your testimony.

REQUIREMENTS FOR SUBMISSION OF MATERIALS - Written testimony may be submitted via email, in person or by U.S. mail to the staff identified on the front of this page. Correspondence should be presented on letter size (8 ½ " x 11") or legal size (8 ½ " x 14") paper. All oversized exhibits <u>must be folded</u> to fit into a legal-sized folder. Plans (i.e. site plans, floor plans, grading plans) must be presented on paper size not smaller than ledger size (11" x 17"). The case number must be written on all communications, plans and exhibits. **To the extent possible, please <u>also</u> submit all materials electronically (flash drive, CD or via email).**

Regular Submissions

- <u>Matters before Commissions</u>: Written materials not limited as to volume must be <u>received</u> ten (10) days prior to the hearing date. Provide an <u>original</u> plus <u>twelve</u> (12) <u>copies</u> of all correspondence or exhibits. You may submit written testimony to the Commission Office directly at 200 North Spring Street, Room 532, Los Angeles, CA 90012 in attention to the Commission Secretariat.
- <u>Matters before an Associate Zoning Administrator (AZA) or Hearing Officer:</u> Written materials not limited as to volume must be <u>received</u> no later than **five (5) days** prior to the hearing date. Provide an **original** plus **(3) copies**, and follow the size guidelines above.

Rebuttal Submissions - All written materials in response to a Recommendation Report and/or additional comments must be submitted no later than **48 hours** before the hearing date. Submissions, including exhibits, shall not exceed ten (10) pages.

Day of Hearing Submissions - Submissions less than 48 hours prior to, and including the day of the hearing, must not exceed two (2) written pages, including exhibits. Photographs do not count toward the page limitation. Notwithstanding, the Associate Zoning Administrator or Hearing Officer may deviate from this requirement at their discretion.

Non-Complying Submissions - Submissions that do not comply with these rules will be stamped *"File Copy. Non-complying Submission"*. Non-complying submissions will be placed into the official case file, but they will not be delivered to, or considered by the Commission, Associate Zoning Administrator or Hearing Officer. Notwithstanding, the Associate Zoning Administrator or Hearing Officer may deviate from this requirement at their discretion.

EXHAUSTION OF ADMINISTRATIVE REMEDIES AND JUDICIAL REVIEW - If you challenge these agenda items in court, you may be limited to raising only those issues you or someone else raised at the public hearing agenized here, or in written correspondence on these matters delivered to this agency at or prior to the public hearing. If you seek judicial review of any decision of the City pursuant to California Code of Civil Procedure Section 1094.5, the petition for writ of mandate pursuant to that section must be filed no later than the 90th day following the date on which the City's decision became final pursuant to California Code of Civil Procedure Section 1094.6. There may be other time limits which also affect your ability to seek judicial review.

ACCOMMODATIONS - As a covered entity under Title II of the Americans with Disabilities Act, the City of Los Angeles does not discriminate on the basis of disability.
