THIS DOCUMENT COMPRISES THE SECOND AND FINAL PART OF THE ENVIRONMENTAL IMPACT REPORT (EIR) FOR THE PROJECT DESCRIBED. THE DRAFT EIR AND THE DEIR SUPPLEMENT, WHICH WERE PREVIOUSLY CIRCULATED FOR PUBLIC REVIEW AND COMMENT COMPRISE THE FIRST PART.

Project Description: The proposed project generally consists of the addition of six new three-story buildings to an existing 260-unit apartment complex. The new apartment buildings, with a total of 141 units, would be constructed on areas now occupied primarily by parking garages, driveways, laundry facilities, and limited landscaping along an existing on-site east-west access road. All existing apartment buildings and landscaped courtyards would be preserved. In addition, the project would expand 11 of the 260 existing apartments with additional bathrooms and bedrooms, and add a swimming pool and gym to the site. The project would result in a net increase of 286 parking spaces, including 88 surface parking spaces. When the project is completed, the site would consist of a total of 401 dwelling units and approximately 546 parking spaces. The site has been designated as a Historic-Cultural Monument by the City of Los Angeles, and is subject to a Mills Act contract. Both the State Historic Preservation Office and the U.S. Department of the Interior have determined that the project is consistent with the U.S. Secretary of the Interior's Standards for Historic Resources. The applicant is applying for a Vesting Tentative Parcel Map, Findings for Site Plan Review, and will require Building Permit clearances (including Historic Resources), as well as Building, Grading, and other applicable ministerial and discretionary permits.
